# **No on 75 - A Message That Bears Repeating**

I know in the last edition of The Bulletin we talked about Proposition 75 on November's special election ballot. However, this measure could be so devastating to all working Californians that it needs repeating.

Prop 75 is the governor's way of silencing the very powerful and influential voice of California state employee unions. If passed, Prop 75 would require the unions to get written permission from their members each year before any dues money could be used for political purposes. It would also limit the amount of money labor could donate to important ballot initiatives.

California state employee unions are one of the strongest and leading labor organizations in the country. They have helped pass significant laws on the state and federal levels that protect you on and off the job. They have backed and help elect pro-labor candidates who care about working Californians – whether you belong to a union or not. They carefully monitor politicians and legislation concerning today's critical issues: pension reform, Social Security, health care, job safety, and education.

We – working Californians – cannot allow the governor and his cronies (the measure received a huge donation from the Small Business Action Committee, a Schwarzenegger-aligned group funded by large corporations and wealthy businessmen) to curtail the important political work done by the state employee unions.

I am highly encouraging you to vote No on Prop 75. Please share this information with your non-union friends and family and help persuade them that should this measure pass, every working Californian will suffer.

Let your voice be heard. Please make time to vote on Nov. 8<sup>th</sup> or take a moment to file absentee. In addition to Prop 75, there are seven other measures that could affect you and your family. It's important that you become educated on the issues and exercise your constitutional right. # Wal-Mart Cries Foul in an Ironic Twist

*“Wal-Mart is asking for an antitrust investigation of a competitor?” asked Albert Foer, president of the American Antitrust Institute in Washington, a think tank. “How delicious.”*

In early September, the *Los Angeles Times* reported that Wal-Mart’s CEO, H. Lee Scott, Jr., told a London newspaper that British powers-that-be should be “concerned about a retail chain having too much market clout.”

How ironic. For years, the nation’s #1 retailer with the world’s largest workforce of 1.6 million people, has flattened mom-and-pop businesses as well as major retailers. It has demanded the lowest prices from suppliers, destroyed communities and skirted taxes. In this country, Wal-Mart commands 10% of total retail business. Worldwide, reported sales were \$285 billion in 2004.

It seems as though Wal-Mart does not have the lion’s share of the retail market in Britain. That crown goes to Tesco, which – like its counterpart offering discounted wares – rings up a resounding 30% of the food market. Wal-Mart owns Asda Group Ltd., and with 16% of the market, it is the second largest retail chain.

According to the *LA Times* article, Scott told the *Times of London*, “As you get over 30% and higher, I am sure there is a point where government is compelled to intervene, particularly in the U.K. where you have the planning laws that make it difficult to compete.”

Wal-Mart bought Asda Group, Ltd. in 1999. Company officials in Britain began back-pedaling after Scott’s comments were published, saying he wasn’t

## Paramount's huge and costly sci-fi production premieres

# T H R E S H O L D

**A**fter several months of long hours, elaborate sets, huge location shoots, crew speculation and critics' anticipation, the new alien drama *Threshold* has barreled out of the gate to great reviews.

That's welcome news to the 728 lighting and rigging crews whose talents and professionalism have enhanced the edgy and dark sci-fi thriller.

"In the end, everything we've done is working. Some rigging may come down and be changed, but all the options we gave ourselves are working," CLT Bobby Ferrara noted.

With his feature film and television background, Ferrara said producers gave him the green light to go big in the beginning. "The best part is they started with 'Let's do a big show.' There weren't a lot of

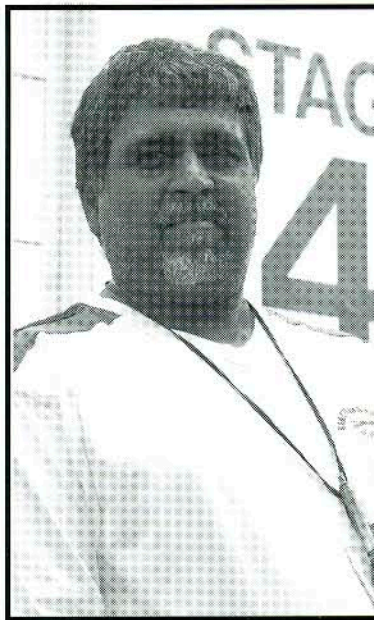

limits. They let us go. We got to rig three stages at Paramount. They put a lot of money into getting it going and gave us the resources," he added.

That included a highly talented crew headed by Rigging Gaffer Gihan "Sandy" Seneviratne. "Our biggest challenge has been trying to keep up with the rush they are in. This is a run and guns kind of show. There are a lot of script changes that happen during the week ... we just work around it and try to accommodate them."

Ahead of the game, and behind it, is Seneviratne's crew: ACLT Greg Cantrell; Paramount ACLT Patric Abaravich; and riggers Doug Byers, John Amorelli, Chris Lama and Lawrence Monier. The group has rigged *Threshold's* very large main set on Stage 5, while Stages 6 and 7 are swing sets.

But with a production that spends roughly three days out on elaborate locations, added manpower and having multiple locations ready to go is commonplace. "We've done some incredible and difficult location shoots; a high voltage power plant, on a naval ship and at USC. There's really nothing like it on TV. This production is being done like a movie," Seneviratne noted.

However, currently filming episode #7 out of a scheduled 13, things may be changing. "It seems as if the intention is to scale things down in terms of writing and not use as many big locations," ACLT David Youel commented. "The scripts don't seem as big, but it's very hard to tell. As far as

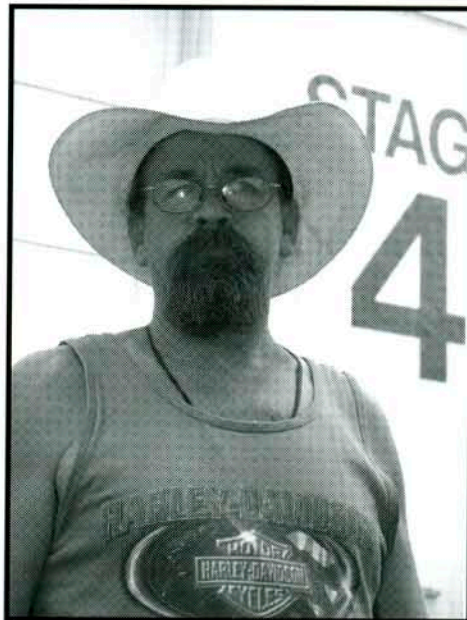
manpower, Sandy and I have been challenged, to put it politely, with our resources. We've had our manpower cut a lot and are having to come up with very creative ways to get things done."

Logging the nearly 70-hour work weeks with Ferrara and Youel is the core lighting crew of Darrin Hill, Alex Jaworski, Robert Ogden, John Linares and Dimmer Board Operator Lance Dickinson.

"This is a collaborative effort by all the members. My best boy, lighting crew and rigging crew are thinking ahead of me and backing me. They're incredible," Ferrara proudly pointed out. "We light shot to shot and moment to moment in a very modern version of old school techniques. Being well prepared on the rigs beforehand allows us to be very flexible. Location after location and on the sets, Sandy and his crew have rigged us for every possibility they could think of."

"We did a scene where a subway train is rushing by the three main characters. We used a row of image 80s that we programmed the chase for to get the flashing effect. It worked amazingly well," Yoel explained. "In order to get it set up and moved around, everyone had to have a great deal of responsibility and know what they were doing. We put it together rather quickly and it

# Hodge Podge 2005

**G**reetings everybody! This has been a very busy month. Rather than concentrate on one theme this month, I will briefly delve into a few topics.

Last month, I stated the details of how to change your status with the Local when you retire. In brief, to change your status within the Local, whether it be Retirement or Honorable Withdrawal or Withdrawal from Local 728 and the International Alliance, you must fill out the proper paperwork and be current with the present quarter dues at the time of your request. Your change of status will become effective in the following quarter.

Several months ago, I wrote about identity theft. While not on the same topic, but still a nuisance are telemarketers. I received an e-mail from a member informing me that in mid-October telemarketers will have access to our cell phone numbers. I checked this out, and while some Internet sites are reporting this to be 'urban legend', you can protect yourself.

To prevent telemarketers from calling, you have two options: Call the National DO NOT CALL Registry (this site is run by the Federal Trade Commission) at 888.382.1222 from the wired phone or cell phone you want blocked. The second alternative is to go to the Internet and log on to [hppt:/donotcall.gov/](http://hppt:/donotcall.gov/). I have used the phone number and the website and they appear to be safe. This is the same website that was activated several years ago to block telemarketers on land-line phones. I highly recommend going to the website because you can print out verification, via an e-mail, that you have registered in the event that you are overwhelmed with unwanted phone calls and want to file a claim with the Federal Trade Commission.

Best Boys, listen up! When you call the Local to fill a call, please have a call time and directions to the location to where our member is to report. I understand that many shows are poorly organized, but I can not release a call without a call time and directions.

referring to any one retail chain in particular, but was speaking by and large about 'market concentration.'

It appears as though there might be an axe to grind. The *LA Times* article notes that in 2004, Wal-Mart's attempt to purchase the Safeway chain was denied by British authorities. The government said the combination of Asda and Safeway would give the company too much power.

Although Wal-Mart execs say that they are "small potatoes" around the world, in Canada they own 256 stores, where sales have risen to 52%. And while the global giant has basically run amok in the U.S., in 2002 the Federal Trade Commission mandated that Wal-Mart sell four stores – to

The classes we offer are Skills Training and even though they are provided by Contract Services, they should not be confused with the required Safety Pass Program. Our classes are solely for our benefit and we are currently the only Local to be offering Skills Training classes. Next year, I am proposing some new and fun courses but before you can take those classes, you must have taken the Safety Qualified Technician Course, so please sign up for that class today.

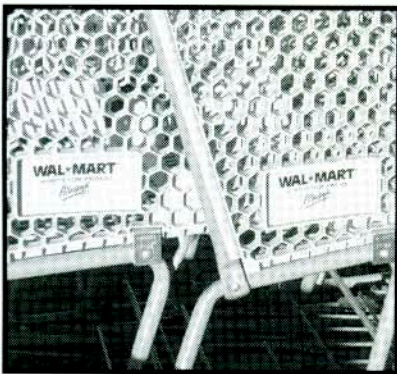
On another note, there have been a few instances across the industry of people getting bacterial infections from working near rodents, wild birds, or other unsanitary conditions. This is a serious issue for us as cable runs through everything and consequently everything gets on our gloves and/or hands. Then a simple itch or wipe of the eyes gives the bacteria an opportunity to infect our bodies.

Regardless of how thoroughly an area has been cleaned prior to our rigging this can happen and when it does, it is a serious problem. The way to deal with this is to first insist that questionable areas be thoroughly cleaned and then wash your hands as often as possible and avoid touching your face or scratching any part of your body. Products like sanitary hand wipes or Purell are very effective as well. A bacterial infection can be disfiguring, deadly, and even in the best case will result in lost work.

A global campaign has been started to slow Wal-Mart's worldwide expansion, and antitrust experts are debating whether the company's immense "buyer power" (known as monopsony) is just as detrimental as the number of retail markets it controls.



Could shining the spotlight on their largest British competitor backfire on Wal-Mart?

*"The unmistakable irony here is that Wal-Mart is accusing its British competition of accomplishing exactly what it has planned for its U.S. operations," said Andrew Grossman, executive director of Wal-Mart Watch, an anti-Wal-Mart coalition supported by some of America's leading unions.*

looked amazing. That's the kind of stuff everyone on the show has to be ready for. I'm glad we're not troubled or challenged by these kinds of things."

The lighting specialists are also using a lot of saturated colors – deep yellows, ambers and blues. "We virtually have everything on dimmer board which allows us to work very fast doing complex lighting," Ferrara noted.

While the riggers and lighting crews have professionally met every conceivable challenge thrown at them, one standard on the production they're ready to change is the exhausting days. "The hardest thing has been the hours ... they've been enormous. Seventy hours has been normal, but it's starting to get better," Ferrara said. "It's becoming a tighter ship. Everyone is trying to find their way and work within their budget. The good thing about it is we started as big as we wanted to be. We put in the best rig and established how to have the right amount of people in the first place."
