Some thoughts before you pull that lever in November

In April, just a few of us concerned Local 728 members joined thousands of activists in a three-day "Hollywood to the Docks" march that ended with a spectacular rally at the Port of Los Angeles in San Pedro.

I found the outpouring of solidarity impressive. The massive group was made up of civic and community leaders, citizens from faith-based organizations and non-union working families struggling to stay afloat.

Along the route, union members were flanked by thousands of concerned citizens from throughout the region who were committed to raising awareness on issues negatively impacting working families including state budget cuts, the lack of affordable housing and access to reasonably priced, quality healthcare.

According to the LA County Federation of Labor, this year more than 350,000 workers, belonging to 30 local unions, will re-negotiate their union contracts. This is the largest number of workers in the history of the LA labor movement.

While we have a team of negotiators bargaining our new contract that protect our wages and benefits, what about our non-union family members? ... our neighbor? ... or the family that runs the dry cleaners? Shouldn't they, too, be able to make ends meet and have access to affordable health care? We are union members, but we're all

Americans first.

In November, we're going to have make a serious decision of who we put into office. Our vote should be for whoever's platform and history will include representing and protecting the interests of all Americans. We need to choose someone who believes in honest government, energy independence, retirement security, and election reforms. We need to choose someone who believes in protecting the environment, protecting Labor by re-aligning Labor in the National Labor Board and the importance of national security, and we need to choose someone that will reform our broken, battered, for-profit health care system – which will in turn benefit all.

It's critical that we don't pull the lever in November based on sound bites. This election is too important. It's imperative that we, along with every other voter, research all presumptive presidential candidates and where they stand on the Iraq War, Social Security, the National Labor Board, taxes and the deficient, veterans benefits, the environment and civil rights. What you discover may be shocking, but please do your homework before November. Don't let a wrong, uninformed choice turn around and bite ALL American workers, Union or not, in the ass.

In the 9th grade, Alison won the

CALL STEWARD

Any Local 728 member representing the producer in filling calls or needing assistance, should contact the Local office during normal business hours. The Local's normal operating hours are 8:00 a.m. to 6:00 p.m. Monday through Friday.

If you need to hire prior to 8:00 a.m., after 6:00 p.m. or over the weekend, please phone the Call Steward at 818-438-0728.

Members seeking weekend work should call the Steward at the Local on Friday to put your name on the Weekend Availability List.

Anyone who hires off roster or hires any member who is not current with their dues without first calling the Call Steward, shall have charges filed against them and shall be subject to the assessments levied by the Trial Board if found guilty.

Cable Management & Inclement Weather

o matter what you call it, cable management is one of our biggest challenges. Like the rest of our equipment, we often push cable to the limits of what it can handle. When cable is pushed past its limit, it not only can cause a problem for us but an unseen problem for the next crew. This applies equally to 4/0 as it does to multi-cables like socapex.

We may not realize it, but we practice cable management when we calculate voltage drop on our feeder circuits. Not overloading the cable is the first step towards protecting the cable from damage. It is equally important to manage the amount of heat that can build up in the cable. If you are on a dimmer rig, a good way to manage the heat in your cable is to take the lights out between set-ups. It is important to note that you have to take the lights out. If you simply take them down, you may actually increase the heat in the cable and compound the problem you are trying to eliminate.

I have written about multi-conductor cable before, but it is important to mention it again in this context. We have to be very specific in how we rig & manage our multi-cables. The manufacturers that make these cables build them to specifics that allow them to be rated at 20amps per circuit. However, just as we don't expect 4/0 to carry 360 amps for 400', we should not expect a multi-cable circuit to carry 16amps for 400'. Since we cannot parallel the conductors inside a multi-cable, we have to take other measures to protect it. Just like 4/0, the length of the run has a huge influence on what can be the maximum sustained load. 20amp loads over a long distance can result in significant color temperature drop and sustained loads carry a risk of melting the cable. Your maximum amperage for a sustained load will depend on several factors including distance and ambient temperature. It may be acceptable (depending on your circumstances) to put 2k loads on multi-cable circuits if you manage the cable properly by taking the lights out at every opportunity to keep from overheating the cable.

An added benefit to taking out your dimmercontrolled lights between takes is that is a move towards being "green" which many studios are embracing. When the lights are off, not only do they require less fuel to be consumed, they are also generating less heat. Less heat means less air conditioning, which means a greater savings on fuel costs. This can be a way to "make points" with the UPM and help them feel that we do care about keeping costs down.

Inclement weather and lightning has come front & center again in our consciousness. *Safety Bulletin #38 Inclement Weather* addresses this issue and recommends that in addition to condors being taken down, that generators



also be powered down in the presence of



lightning Safety Bulletin #38 also recommends that the set have an Action Plan in place whenever shooting in an area where inclement weather is likely. Part of this plan should include a protocol for powering down the generators without causing a hazard to the set or base camp. Unless an emergency situation exists, the generator should not be powered down without first notifying the Gaffer who can relate the information to production and ensure everyone is safe prior to going dark. If you are in a location where you think that rough weather is likely, and an Action Plan has not been established, take it upon yourselves to establish a protocol for how to power down the generators and effectively notify everyone who will be affected.

One big question is "How close is too close?" This is not addressed in Safety Bulletin #38 so this is something else you should work out with production prior to shooting. Keep in mind that lightning can strike up to 10 miles from where it originated and storm fronts can travel in excess of 50 miles an hour. When in an area where storms are likely, it may be necessary to keep an eye on the weather forecast to stay one step ahead of the weather.

No member shall be permitted to accept a nomination for more than one (1) office, this not to include nominations for election of delegates to conventions or Central Labor Council. **Section 6–NOMINATIONS AND REQUEST FOR NOMINATIONS**


a). In order to assure the most democratic nominations possible, all nominations will take place on the floor at the Membership meeting regardless of odd or even year, and that notice of such nominations to take place shall be put in Local 728 monthly newsletter "THE BULLETIN" prior to the meeting.

b). Any Member working in our jurisdiction, on the day of nomination, may send the Local a written request to place his name in nomination for any office; said request to be placed in nomination by the presiding officer of the meeting.

Section 7 – ELIGIBILITY

A person must have been a member of Local 728 for a period of two (2) years before he can become a candidate for any office, and further must be in good standing at the time of nomination. A member in good standing shall be any person who is not in arrears and who neither has voluntarily withdrawn from membership nor become inactive from membership nor has been expelled or suspended from membership.
